8. Discuss the material factors that make an investment in the issuer speculative or risky:

Windlift is building a novel airborne power system. While prototypes are flying and generating power, continued reliability, scalability, and integration with customer payloads remain in development.

As a hardware and infrastructure company, Windlift requires significant upfront capital to scale production and field operations. Delays in funding or cost overruns could impact speed of growth.

Windlift is creating a new product category, while it has sole source justification with DOD, it may face competition from entrenched energy providers, emerging drone tech companies, or ISR platforms as the commercial market matures.

Customer adoption depends on ease of deployment, proven system reliability, and integration with existing operations. Mission-specific pilots are important to drive broader contracts.

Achieving cost-competitiveness in the energy market(\$/kWh) relies on scaling manufacturing, supply chain reliability, and successfully implementing design-for-manufacture improvements.

Windlift's initial traction is driven by U.S. Department of Defense contracts. While commercial expansion is planned, current revenues are concentrated and may be affected by shifts in government priorities or budgets. Defense and energy generation are priorities of the current administration, but this can change.

Operating tethered drones at scale will require coordination with FAA and international regulators. We plan to start this process before operationally necessary, but changes in policy or permitting delays could affect deployment timelines.

Windlift's technology has both defense and commercial applications, which may subject it to U.S. export control laws (e.g., ITAR or EAR). Regulatory compliance could impact international sales, partnerships, or deployment speed in allied markets.

The price per share of the current round was based on the full conversion of SAFE holders into 606,458 preferred shares pursuant to the terms of the SAFEs. The Convertible note holder has a right to convert their principal plus interest as of 7.23.25 into 86,909 preferred shares at a \$16m post-money valuation cap per the terms of the agreement with the convertible note holder. We have also authorized an additional 7,841 preferred shares to account for the interest that could accrue through 12.31.25 because we assume as a company that we will have a decision from the convertible note holder to convert or Windlift will decide to pay off principal plus interest by that date.

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. This means that the investor will not receive a certificate representing his or her investment. Each investment will be recorded in the

books and records of the SPV. In addition, investors' interests in the investments will be recorded in each investor's "Portfolio" page on the Wefunder platform. Windlift, Inc is offering up to 48,780 shares of Series Seed Preferred Stock, at a price per share of \$8.20.

The campaign maximum is \$399,996.00 and the campaign minimum is \$50,000.00.

Securities issued by the SPV

Instead of issuing its securities directly to investors, the Company has decided to issue its securities to the SPV, which will then issue interests in the SPV to investors. The SPV is formed concurrently with the filing of the Form C. Given this, the SPV does not have any financials to report. The SPV is managed by Wefunder Admin, LLC and is a co-issuer with the Company of the securities being offered in this offering. The Company's use of the SPV is intended to allow investors in the SPV to achieve the same economic exposure, voting power, and ability to assert State and Federal law rights, and receive the same disclosures, as if they had invested directly in the Company. While the Issuer may be required to pay an annual administrative fee for the maintenance of the SPV, investors should note the Company's use of the SPV will not result in any additional fees being charged to investors.

The SPV has been organized and will be operated for the sole purpose of directly acquiring, holding and disposing of the Company's securities, will not borrow money and will use all of the proceeds from the sale of its securities solely to purchase a single class of securities of the Company. As a result, an investor investing in the Company through the SPV will have the same relationship to the Company's securities, in terms of number, denomination, type and rights, as if the investor invested directly in the Company.

Voting Rights

If the securities offered by the Company and those offered by the SPV have voting rights, those voting rights may be exercised by the investor or his or her proxy. The applicable proxy is the Lead Investor, if the Proxy (described below) is in effect.

Proxy to the Lead Investor

The SPV securities have voting rights. With respect to those voting rights, the investor and his, her, or its transferees or assignees (collectively, the "Investor"), through a power of attorney granted by Investor in the Investor Agreement, has appointed or will appoint the Lead Investor as the Investor's true and lawful proxy and attorney (the "Proxy") with the power to act alone and with full power of substitution, on behalf of the Investor to: (i) vote all securities related to the Company purchased in an offering hosted by Wefunder Portal, and (ii) execute, in connection with such voting power, any instrument or document that the Lead Investor determines is necessary and appropriate in the exercise of his or her authority. Such Proxy will be irrevocable by the Investor unless and until a successor lead investor ("Replacement Lead Investor") takes the place of the Lead Investor. Upon notice that a Replacement Lead Investor has taken the place of the Lead Investor, the Investor will have five (5) calendar days to revoke the Proxy. If the Proxy is not revoked within the 5-day time period, it shall remain in effect.

Restriction on Transferability

The SPV securities are subject to restrictions on transfer, as set forth in the Subscription Agreement and the Limited Liability Company Agreement of Wefunder SPV, LLC, and may not be transferred without the prior approval of the Company, on behalf of the SPV.

The holders of a majority-in-interest of voting rights in the Company could limit the Investor's rights in a material way. For example, those interest holders could vote to change the terms of the agreements governing the Company's operations or cause the Company to engage in additional offerings (including potentially a public offering).

These changes could result in further limitations on the voting rights the Investor will have as an owner of equity in the Company, for example by diluting those rights or limiting them to certain types of events or consents.

To the extent applicable, in cases where the rights of holders of convertible debt, SAFES, or other outstanding options or warrants are exercised, or if new awards are granted under our equity compensation plans, an Investor's interests in the Company may be diluted. As holders of a majority-in-interest of voting rights in the Company, **the shareholders** may make decisions with which the Investor disagrees, or that negatively affect the value of the Investor's securities in the Company, and the Investor will have no recourse to change these decisions. The Investor's interests may conflict with those of other investors, and there is no guarantee that the Company will develop in a way that is optimal for or advantageous to the Investor.

For example, **the shareholders** may change the terms of the Articles of Incorporation for the company, change the terms of securities issued by the Company, change the management of the Company, and even force out minority holders of securities. **The shareholders** may make changes that affect the tax treatment of the Company in ways that are unfavorable to you but favorable to them. Overview

Built with DOD & DOE. An autonomous tethered platform that delivers power and awareness from above.

Windlift, Inc. is a Delaware-based corporation specializing in autonomous airborne power systems and persistent elevated sensing solutions. Originally founded in North Carolina in 2015 and incorporated in Delaware in 2019, the company serves both defense and commercial sectors with its tethered drone platforms, delivering energy and communications in remote and infrastructure-limited environments.

Milestones

Windlift, Inc. was incorporated in the State of Delaware in August 2015. Windlift, Inc. was originally formed as a limited liability company (LLC) in the state of North Carolina on August 19, 2015. On November 18, 2019, the company converted to a corporation and was reincorporated in the state of Delaware.

Since then, we have:

- Aerial infrastructure poised to disrupt \$200B+ in global defense and commercial markets
- Built with \$24M+ in DOE & DOD contract revenue to date - \$7.39M in 2024
- Secured SBIR III + sole source: a rare combo awarded to 0.6% of federally backed companies
- Generates and delivers 24/7 energy to on-board integrated technology and the ground station below
- Host and enabler of major DOD prime technologies (sensors/cameras/SAR) - partnerships in process
- Technical oversight and continuous validation from the Naval Research Lab
- Built by experts in defense, aerospace, and autonomy with a team from NASA, Battelle, Caterpillar...
- MOU with Sandia National Labs for Development and Commercialization of Autonomous Airborne Power

Historical Results of Operations

- *Revenues & Gross Margin.* For the period ended December 31, 2024, the Company had revenues of \$7,391,213 compared to the year ended December 31, 2023, when the Company had revenues of \$2,227,853. Our gross margin was 46.36% in fiscal year 2024, and 51.86% in 2023.
- *Assets.* As of December 31, 2024, the Company had total assets of \$1,684,185, including \$247,679 in cash. As of December 31, 2023, the Company had \$1,312,732 in total assets, including \$885,774 in cash.
- *Net Income.* The Company has had net income of \$665,201 and net losses of \$781,257 for the fiscal years ended December 31, 2024 and December 31, 2023, respectively.
- *Liabilities.* The Company's liabilities totaled \$4,328,938 for the fiscal year ended December 31, 2024 and \$4,629,522 for the fiscal year ended December 31, 2023.

Liquidity & Capital Resources

To-date, the company has been financed with \$80,000 in equity, \$250,000 in convertibles, \$2,817,579 in debt, and \$1,881,412 in SAFEs.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 3 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 1 month. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

Runway & Short/Mid Term Expenses

Windlift, Inc cash in hand is \$375,534, as of July 2025. Over the last three months, revenues have averaged \$150,849/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$475,216/month, for an average burn rate of \$324,367 per month. As of July 2025, our burn rate has decreased to approximately \$130,000 per month. Our intent is to be profitable in 3 months.

Since the close of the last reported financial period, the Company has entered a temporary pause in revenue that began in May 2025. This is due to the completion of Task Order 1 under the Company's SBIR Phase III contract and the ongoing process of defining the scope and execution plan of a follow-on task order. In response, the Company has reduced its monthly operating expenses to approximately \$130,000 as of July 2025. This cost reduction is part of a broader strategy to preserve capital while focusing operational efforts on preparing for potential follow-on government contracts and identifying suitable commercial and defense partners for future deployment of the Company's platform technology.

The Company does not currently have committed revenue for the next 3–6 months. The Company is actively engaged in multiple government and commercial opportunities that could result in future revenue, but there is no guarantee that these efforts will result in signed contracts or recognized revenue. Potential government contract opportunities include: A bridge program through the Department of Defense's Operational Energy Office, with anticipated task orders in the range of \$2 million to \$5 million; A DARPA program in partnership with a major defense prime contractor, for which a proposal has been submitted. If awarded, revenue would be recognized across 2025 and 2026; The Army's XTech Overwatch initiative, expected to begin in 2025 if awarded with potential revenue extending into 2026; Additional identified opportunities with the U.S. Coast Guard and the Department of Homeland Security (DHS), where the Company believes its technology aligns with known operational needs. On the commercial side, the Company is engaged in early-stage customer discovery with international shipping companies regarding its maritime awareness platform extending the DARPA program into commercial markets. We are defining use cases, deployment models, and pricing strategies with the goal of leading to pilot programs or commercial contracts. The Company has historically secured over \$24 million in federal contracts and holds an open Indefinite Delivery Indefinite Quantity (IDIQ) contract with the Department of Defense. The timing of future contracts remains uncertain due to delays in the federal budget process for Fiscal Year 2025 and other external factors. To support operations and the pursuit of revenue-generating contracts and commercial deployment, the Company is currently raising up to \$3 million through a combination of Regulation CF and parallel Regulation D offerings. Depending on capital needs, the company also plans to raise up to an additional \$10 million through a follow-on Regulation D offering. We expect our expenses will go down for July and beyond to \$130,000 per month as we prepare for incoming contracts and investment and we will not increase expenses until revenue is defined.

The Company was profitable in the fiscal year 2024, generating \$7.39 million in revenue and approximately \$665,201 in net income. In 2025, the Company made a strategic decision to increase investment in technology development. As a result, the Company incurred a net loss of approximately \$1 million in the first half of 2025. At the time of this filing, the Company is not currently profitable and does not have active revenue-generating contracts. The Company is between task orders on its SBIR Phase III contract but holds an open Indefinite Delivery Indefinite Quantity (IDIQ) contract with the Department of Defense. The Company is actively working to define the scope of a follow-on task order. The slowdown in federal contract awards due to delays in the Fiscal Year 2025 federal budget process has affected timing across the industry. The Company anticipates that future government and commercial contracts may resume in the coming months but there is no guarantee as to if or when such contracts will be awarded. To bridge this gap, the Company is currently raising capital to support operations, advance product readiness, and pursue both defense and commercial contract opportunities. While the Company may achieve profitability upon resumption of contract activity, it may also choose to reinvest available capital to support long-term growth, depending on strategic priorities and market conditions.

The Company intends to cover short-term operating expenses during the campaign period using a combination of existing cash on hand, proceeds from a simultaneous Regulation D offering, and any revenue-generating contracts that are awarded during this time. The Company has authorized up to \$3 million in total fundraising at the current valuation across both Regulation CF and Regulation D offerings. As of the date of this filing, the Company has received approximately \$50,000 in signed commitments under the Regulation D offering. The Company may raise up to an additional \$10 million in near-term capital through a follow-on Regulation D offering, depending on capital needs for growth. There is no guarantee that any of these offerings will be fully subscribed or that additional capital will be secured.

As described above, each Investor that has entered into the Investor Agreement will grant a power of attorney to make voting decisions on behalf of that Investor to the Lead Investor (the "Proxy"). The Proxy is irrevocable unless and until a Successor Lead Investor takes the place of the Lead Investor, in which case, the Investor has a five (5) calendar day period to revoke the Proxy. Pursuant to the Proxy, the Lead Investor or his or her successor will make voting decisions and take any other actions in connection with the voting on Investors' behalf.

The Lead Investor is an experienced investor that is chosen to act in the role of Lead Investor on behalf of Investors that have a Proxy in effect. The Lead Investor will be chosen by the Company and approved by Wefunder Inc. and the identity of the initial Lead Investor will be disclosed to Investors before Investors make a final investment decision to purchase the securities related to the Company.

The Lead Investor can quit at any time or can be removed by Wefunder Inc. for cause or pursuant to a vote of investors as detailed in the Lead Investor Agreement. The identity of the Successor Lead Investor will be disclosed to Investors, and those that have a Proxy in effect can choose to either leave such Proxy in place or revoke such Proxy during a 5-day period beginning with notice of the replacement of the Lead Investor.

The Lead Investor will not receive any compensation for his or her services to the SPV. The Lead Investor may receive compensation if, in the future, Wefunder Advisors LLC forms a fund ("Fund") for accredited investors for the purpose of investing in a non-Regulation Crowdfunding offering of the Company.
