The Company's costs for developing the film may exceed expectations and, as a result, the Company may need additional financing.

If the Company is not able to contain its development and operational budgeted costs or keep them at or under the projected costs, then the Company may need to raise additional capital. No assurance can be given that the Company will be able to control its expected costs or that the Company will be able to secure additional financing, if needed, on favorable terms, or at all. Further, if the Company issues equity securities to raise additional funds, the investors in this offering may experience dilution or the new equity securities may have rights, preferences or privileges senior to those of existing holders of the Preferred Units. If the Company's costs exceed projections or if it cannot raise funds, if needed, on acceptable terms, such factors could have a material adverse effect on the Company's business, financial condition or results of operations and on the value of the Preferred Units.

The Company's revenues could decline if it fails to meet its production goals and release schedule.

The production and distribution of the film is subject to numerous uncertainties, including financing requirements, the availability of desired talent to finish production, the distribution release schedule and the films of the Company's competitors. If the Company fails to meet its production goals and release schedule, its revenues could decline. The Company cannot assure investors that its production goals will be met. The Company also cannot assure investors that the film will be completed on budget, or at all, or released following completion.

The Company will rely on the managerial abilities of the Managers.

The ability of the Company to produce the film and all of the related activities will depend in part upon the managerial abilities of the Managers. Ryland Tews has prior movie industry experience and has experience producing several films. Ryland Tews will devote to the Company's affairs only such time as he deems necessary. Ryland Tews is presently engaged, and anticipates that he will continue to be engaged, in substantial business and other activities in addition to those of the Company, all of which impose substantial demand on the time and effort of the Company's members. The unavailability of the Company's members could also have a material adverse effect on the Company.

The Company's revenues and results of operations may fluctuate unexpectedly due to factors such as the timing of release of the Company's film, public acceptance of the competition in

such as the timing or release of the Company's film, public acceptance of the competition in the marketplace and other factors that the Company cannot control.

The Company's revenues and results of operations may fluctuate significantly and unexpectedly from period to period, and the results of any one period may not be indicative of the results for any future period. The Company cannot assure the economic success of the film because the production, completion and distribution of the film are subject to numerous uncertainties, including financing requirements, the availability of creative production and marketing talent, the release schedule of competing films, acceptance by the public and other factors.

The Manager will have discretion as to the use of proceeds in this Offering.

We anticipate using the net proceeds of the offering to fund the pre-production, production, post-production, marketing and distribution of the film. A portion of the proceeds will be used to pay legal fees and other expenses incurred in connection with this offering. Despite such anticipated uses, the Manager has discretion to spend the proceeds from this offering in ways with which the investors may not agree or in ways that do not prove to be advantageous to the Company.

There may be conflicts of interest on the part of the Managers.

During the term of the Company, it is possible that conflicts will arise between the interests of the Managers and those of the investors. Such conflicts may include the promotion by the Managers of other projects that may compete with the film. The Managers and their affiliates also will perform services for, and receive fees from and ownership interests in the Company, which are not the result of arms-length negotiations. There can be no assurance that such conflicts will not have an adverse effect on the development and operation of the business.

The investors will have no ability to control the Company's operations.

The Manager will have exclusive authority to direct the Company's operations. Accordingly, the investors will have no right or power to take part in the management or control of the Company's business. The Managers may only be removed by the affirmative vote a majority of the then outstanding Class A Common Units, which are held by Ryland Tews.

A downturn in the economy generally may have a material adverse effect on the Company. The Company's success depends, in large part, on numerous factors affecting discretionary spending. Therefore, the Company's success is susceptible to global economic conditions. If the general economic health of the United States declines, or if consumers or sponsors fear that economic conditions will decline, consumers may reduce expenditures for products such as the Company's product. Reductions in consumer spending or in economic conditions could have a material adverse effect on the Company's business, financial condition or results of operations and the value of the Preferred Units.

The minimum budget we will need to create the film is \$2M. This is higher than our minimum and maximum funding target on Wefunder. In the case that we don't raise the minimum budget through Wefunder, we plan to raise additional funds outside of Wefunder from existing investor relationships from previous films.

Our future success depends on the efforts of a small management team. The loss of services of the members of the management team may have an adverse effect on the company. There can be no assurance that we will be successful in attracting and retaining other personnel we require to successfully grow our business.

Ryland Tews is a part-time officer. As such, it is likely that the company will not make the same progress as it would if that were not the case.

### USE OF FUNDS

The Company intends to use the net proceeds of this offering for working capital and general corporate purposes, which includes the specific items listed in Item 10 below. While the Company expects to use the net proceeds from the Offering in the manner described above, it cannot specify with certainty the particular uses of the net proceeds that it will receive from this Offering. Accordingly, the Company will have broad discretion in using these proceeds.

10. How does the issuer intend to use the proceeds of this offering?

If we reach our target offering amount prior to the deadline, we may conduct an initial closing of the offering early if we provide notice about the new offering deadline at least five business days prior to the new offering deadline (absent a material change that would require an extension of the offering and reconfirmation of the investment commitment). Wefunder will notify investors if we conduct an initial closing. Thereafter, we may conduct additional closings from time to time at our and Wefunder's discretion until the deadline date.

The following describes the process to invest in the Company, including how the Company will complete an Investor's transaction and deliver securities to the investor.

1. **Investor Commitment.** The Investor will submit, through Wefunder Portal, a requested investment amount. When doing so, the Investor will also execute an investment contract with the Company ("Investment Agreement"), using the Investor's electronic signature.
2. **Acceptance of the Investment.** If the Investor Agreement is complete, the Investor's commitment will typically be recorded within a few minutes. **Film Financing Waterfall Agreement:** Investors receive the Financing Amount together with a **thirty percent (30%) premium**, and then share in 50% of net receipts after all expenses have been recouped.

**Recoupment.** Provided that Company has completed the Offering, and Financier is not in breach of this Agreement, Company agrees to repay to Financier the Financing Amount, together with a thirty percent (30%) premium thereon ("Financier Recoupment"), solely from Gross Receipts (if any) in accordance with this Paragraph.

"**Gross Receipts**" as used herein shall mean all non-returnable, non-forfeitable sums derived by, or credited to, Company or any of its affiliated or related parties from the distribution, exhibition, and other exploitation of the Picture (but not any sequel), any merchandising, publishing, soundtrack and other allied and/or ancillary rights relating thereto and any other funds received by or credited to Company or any of its affiliated or related parties from the exploitation of the Picture. Gross Receipts, if any, of the Picture shall be allocated in the following order:

a. First, to the payment of the following:

i. Any actual third party, out-of-pocket sales fees and sales expenses payable to the sales agents engaged to sell the Picture and other third party distribution fees and expenses (including but not limited to reasonable outside attorney fees) actually incurred and not otherwise recouped by Company relating directly to the Picture, ongoing third party, out-of-pocket accounting costs and expenses incurred by Company in connection with the processing of payments to profit participants on the Picture;

ii. All other costs, expenses and charges actually incurred and paid by the Company (or any affiliated or related entities) in connection with the production, post-production of the Picture or any rights therein, including, but not limited to, actual, out of pocket third party delivery costs and expenses (exclusive of the budgeted delivery costs), actual, out of pocket third party reasonable festival expenses (e.g., publicist, accommodations for producers, etc.), guild royalties, residuals, the gross amount (net of any insurance proceeds in connection therewith) paid for the settlement of any claims or lawsuits, including all expenses, court costs and attorneys' fees in connection with any such claim or litigation; but only to the extent any of the foregoing have not previously been paid or assumed by the Picture's distributor;

iii. Third party, out-of-pocket expenses incurred by Company in connection with the ongoing ownership of the Picture, including but not limited to (e.g., insurance premiums, the preservation and storage of negatives and master prints of the Picture, and copyrighting of the Picture) and maintenance and filing fees required to maintain Company in good standing; taxes and other fees; and any amounts required to be withheld by law, if any; and

iv. Any compensation or deferred compensation and bonuses (e.g., box office bonuses, award bonuses) payable to parties rendering services in connection with the Picture (to the extent not assumed by the distributor(s) of the Picture); market rate compensation payable to the Company or its affiliates for services rendered in connection with the production, completion and delivery of the Picture; any amounts paid to the completion guarantor of the Picture (if any) in repayment of sums advanced by such completion guarantor; any reasonable reserve amount, as determined by Company in its good faith business judgment, required to cover anticipated future costs or liabilities, provided that such reserve amounts shall be liquidated every twelve (12) months.

b. Next, to the payment of any loans, plus reasonable interest thereon;

c. Next, to Financier and any additional financiers (whether such financiers participated in the Offering or through a prior or future private or other capital raise) pro rata pari passu in accordance with their respective funds provided, until all financiers, including **Financier, have received one hundred percent (100%) of the Financing Amount, plus a premium of thirty percent (30%) of the funds provided** by such financier, if ever;

d. Next, for the payment of any actual Deferments, which deferments shall not exceed 20% of the final budget of the Picture. As used herein, "Deferments" shall mean arrangements for the deferral of some or all of the costs of goods and/or services in the Production Budget provided by the supplier of such goods and/or services; and

e. Finally, to Net Receipts. "Net Receipts," as used herein, shall mean One Hundred Percent (100%) of all Gross Receipts remaining after the payments of all amounts set forth in subparagraphs 6(a) through (d) above. **Company shall receive Fifty Percent (50%) of Net Receipts ("Company's Net Receipts") and the other Fifty Percent (50%) of Net Receipts shall be "Financier's Net Receipts."** Financier shall receive such percentage of Financier's Net Receipts equal to the percentage that the Financing Amount advanced to Company represents to the actual Production Budget, which may exceed the estimated Production Budget as set forth herein. - The HoB Blu-ray sold out 8,000 copies in its first nine days after release

- Investment offers potential to recoup 130% of principal plus pro rata share of 50% of the backend

Our company was organized in July 2025 and has limited operations upon which prospective investors may base an evaluation of its performance.

To-date, the company has been financed with \$27,200 in debt.

After the conclusion of this Offering, should we hit our minimum funding target, our projected runway is 3 months before we need to raise further capital.

We plan to use the proceeds as set forth in this Form C under "Use of Funds". We don't have any other sources of capital in the immediate future.

We will likely require additional financing in excess of the proceeds from the Offering in order to perform operations over the lifetime of the Company. We plan to raise capital in 1 months. Except as otherwise described in this Form C, we do not have additional sources of capital other than the proceeds from the offering. Because of the complexities and uncertainties in establishing a new business strategy, it is not possible to adequately project whether the proceeds of this offering will be sufficient to enable us to implement our strategy. This complexity and uncertainty will be increased if less than the maximum amount of securities offered in this offering is sold. The Company intends to raise additional capital in the future from investors. Although capital may be available for early-stage companies, there is no guarantee that the Company will receive any investments from investors.

### **Runway & Short/Mid Term Expenses**

Oriental Snatch, LLC cash in hand is \$2,304.52 as of April 2026. Over the last three months, revenues have averaged \$0/month, cost of goods sold has averaged \$0/month, and operational expenses have averaged \$0/month, for an average burn rate of \$0 per month. Our intent is to be profitable in 24 months.

There have been no material changes or trends in our finances or operations since the date our financials cover. Oriental Snatch LLC is a newly formed entity and we have yet to begin operations on producing the film.

The expenses will all be the production-related payments that need to be made in order to shoot the movie (around \$500k in the next 3-6 months). In order to be revenue generating, we need to raise a minimum of \$1M so we can shoot, edit, and promote the movie upon its release. Revenue will begin in 2027 after the film is released. This will come in the form of box office, rentals, retail sales, and merchandising.

We will not be profitable until 2027 or 2028. Shooting, editing, and releasing a film is a long process. Additionally, we need to sell the film to distributors around the world in order to get the film out to people in theaters, streaming platforms, and blu-ray. This all takes time, but is necessary to make the film profitable. We need a minimum of \$1M to be profitable (\$800k production budget, \$200k marketing budget), because without \$1M, there's no film to sell and make money. Ideally, however, the film is made for \$2-3M. Based on the story and script, a budget like this would make for a better finished product, and thus, yield more profits.

As of now, we have raised \$27,200 outside of Wefunder from two investors. To cover short term burn throughout the campaign, we'll raise funds from outside investors, including those who invested in previous films.

All projections in the above narrative are forward-looking and not guaranteed.
